RELEASE OF INTELLECTUAL PROPERTY SECURITY INTERESTS

This Release of Intellectual Property Security Interests (this "Release") is granted and conveyed as of July 25, 2013 by WELLS FARGO CAPITAL FINANCE, LLC, a Delaware limited liability company ("WFCF"), in its capacity as agent for the Lender Group and the Bank Product Providers (in such capacity, together with its successors and assigns in such capacity, "Assignor"), in favor of Teletrac, Inc., a Delaware corporation and Fleet Management Solutions, Inc., a California Corporation ("Assignees").

WHEREAS, the Assignor and Teletrac Ltd, a company incorporated under the laws of England and Wales (f/k/a Vector Capital Limited) are parties to a Credit Agreement dated as June 2, 2010 ("Credit Agreement").

WHEREAS, pursuant to such Credit Agreement, Assignor and certain of the Assignees entered into that Patent Security Agreement dated as of August 3, 2010 ("Patent Security Agreement") wherein certain of the Assignees assigned to Assignor a security interest in the Patent Collateral (as defined in the Patent Security Agreement), including the items listed on the attached Exhibit A ("Patents").

WHEREAS, pursuant to such Credit Agreement, Assignor and certain of the Assignees entered into that Trademark Security Agreement dated as of August 3, 2010 (the "Trademark Security Agreement") wherein certain of the Assignees assigned to Assignor a security interest in the Trademark Collateral (as defined in the Trademark Security Agreement; the Trademark Collateral and the Patent Collateral are hereby referred to collectively as the "IP Collateral"), including the items listed on the attached Exhibit B ("Trademarks").

WHEREAS, the United States Patent and Trademark Office ("PTO") recorded such Trademark Security Agreement against the Trademarks on August 10, 2010 at Reel/Frame 4257/0892.

WHEREAS, the PTO recorded such Patent Security Agreement against the Patents on August 10, 2010 at Reel/Frame 024812/0823.

WHEREAS, Assignees have satisfied all of their outstanding obligations under the Security Agreement between the parties hereto and Teletrac Holdings, Inc. dated August 3, 2010 (as supplemented, amended, or amended and restated from time to time, the "Security Agreement"), and the parties hereto seek to make a record of Assignor's release and assignment to Assignees of any and all of the rights it may have in the Assignees' Intellectual Property (as defined in the Security Agreement), including the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties hereto acknowledge, Assignor hereby (1) releases, discharges and relinquishes, as of the date hereof, its security interests in the Assignees' Intellectual Property, including the IP Collateral, and (2) assigns to Assignees any and all of the rights, title and interest it may have in the Assignees' Intellectual Property, including the IP Collateral. Assignor hereby specifically acknowledges that the Security Agreement is no longer effective and that it does not own any rights to or have any ownership interest in the Assignees' Intellectual Property, including the IP Collateral, and all of its rights and remedies with respect to the Assignees' Intellectual Property, including the IP Collateral, have been and are hereby extinguished.

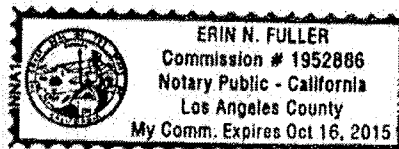
