RELEASE OF TRADEMARK SECURITY INTEREST dated as of August 5, 2013 (this "**Release**"), by Citibank, N.A., as Administrative Agent (as defined below) for the Secured Parties in favor of WP Prism Inc. (n/k/a Bausch & Lomb Holdings Incorporated), Bausch & Lomb Incorporated, ISTA Pharmaceuticals, Inc. and any other Grantors party to (and as defined in) each of the Trademark Security Agreements (as defined below) (collectively, the "**Grantors**"). Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Credit Agreement or the U.S. Security Agreement (each as defined below), as applicable.

A. Reference is made to the Credit Agreement dated as of May 18, 2012 (as amended, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), among Bausch & Lomb Incorporated (the "**Parent Borrower**"), Bausch & Lomb B.V., as Dutch Subsidiary Borrower, WP Prism Inc. (n/k/a Bausch & Lomb Holdings Incorporated) ("**Holdings**"), Citibank, N.A., as Administrative Agent (in such capacity, the "**Administrative Agent**"), Swing Line Lender and an L/C Issuer, JPMorgan Chase Bank, N.A., as an L/C Issuer, and each lender from time to time party thereto (collectively, the "**Lenders**" and individually, a "**Lender**").

B. Reference is made to the U.S. Security Agreement, dated as of May 18, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "**U.S. Security Agreement**"), among Holdings, the Parent Borrower, certain Subsidiaries of the Parent Borrower from time to time party thereto and the Administrative Agent.

C. Reference is made (i) to the Trademark Security Agreement dated as of May 18, 2012 among certain Grantors and the Administrative Agent, (ii) to the Trademark Security Agreement dated as of June 29, 2012 between ISTA Pharmaceuticals, Inc. and the Administrative Agent, (iii) to the Trademark Security Agreement dated as of July 24, 2012 among certain Grantors and the Administrative Agent and (iv) to the Trademark Security Agreement dated as of November 1, 2012 among certain Grantors and the Administrative Agent (collectively, the "**Trademark Security Agreements**").

D. Pursuant to the Trademark Security Agreements, as security for the payment in full of the Obligations, each Grantor granted to the Administrative Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in, all right, title and interest in or to any and all of the following assets and properties then owned or at any time thereafter acquired by such Grantor or in which such Grantor then had or at any time in the future may acquire any right, title or interest, except for any Excluded Assets (collectively, the "**Trademarks**"):

- (a) all trademarks, service marks, trade names, corporate names, trade dress, logos, designs, fictitious business names, other source or business identifiers,

then existing or thereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the USPTO or any similar offices in any State of the United States or any other country or any political subdivision thereof, including those listed on Annex II hereto, and all extensions or renewals thereof, as well as any unregistered trademarks and service marks used by a Grantor;

- (b) all goodwill connected with the use of and symbolized thereby; and
- (c) all assets, rights and interests that uniquely reflect or embody any of the foregoing.

E. The security interest granted pursuant to the Trademark Security Agreement was recorded with the United States Patent & Trademark Office on June 29, 2012 at Reel/Frame 4811/0883, on August 6, 2012 at Reel/Frame 4836/0133, on August 15, 2012 at Reel/Frame 4842/592 and on November 14, 2012 at Reel/Frame 4900/0203.

E. Pursuant to Section 6.12 of the U.S. Security Agreement and the payment in full of all of the Obligations, the Administrative Agent has agreed to release the security interest in the Trademarks.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby absolutely, unconditionally and irrevocably terminate, release, relinquish and forever discharge all right, title and interest (including, without limitation, security interests) of the Administrative Agent in, to and under the Trademarks, including the security interest granted pursuant to the Trademark Security Agreements. The Administrative Agent hereby assigns, transfers and sets over to the Grantors all right, title and interest that the Administrative Agent, and its predecessors, successors and assigns may have in, to and under the Trademarks.

The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America to record this Release against the Trademarks. The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver all further documents and to do all such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby at the cost and request of the Grantors. The execution and delivery of documents or instruments, including this Release, shall be without recourse to, or representation or warranty by, the Administrative Agent.

This Release shall be binding upon the Administrative Agent's successors, assigns and transferees.

THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.
