**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**  
**(Fisher Broadcasting -- Seattle Radio, L.L.C.)**

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, JPMorgan Chase Bank, National Association, a national banking association, as Administrative Agent for the Secured Parties ("Administrative Agent"), pursuant to that certain Credit Agreement dated as of November 19, 2012, among Fisher Communications, Inc., a Washington corporation ("Borrower"), the Lenders party thereto, and JPMorgan Chase Bank, National Association, as Administrative Agent (such agreement, together with all amendments and restatements thereto, the "Credit Agreement"), does hereby terminate and release its interest in and to that specific Trademark Collateral shown on Exhibit "A" attached hereto, namely, those trademarks listed on Exhibit "A" (the "Released Trademarks"), arising from that certain Trademark Security Agreement dated as of November 19, 2012, between Administrative Agent and Fisher Broadcasting -- Seattle Radio, L.L.C., a Delaware limited liability company ("Grantor"), which was recorded in the United States Patent and Trademark Office on or about January 14, 2013, as against the Released Trademarks at Reel/Frame 4942/0191.


