**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), dated as of August 6, 2013, is made by General Electric Capital Corporation, as agent ("Agent"), under that certain Amended and Restated Credit Agreement, dated as of December 28, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement by and among eInstruction Corporation, a Texas corporation ("Borrower"), the other persons from time to time party thereto as "Credit Parties", the financial institutions from time to time party thereto as "Lenders" (the "Lenders"), and Agent.

(the "Grantors"), the Lenders from time to time party thereto the Agent, and any other parties thereto, the Lenders made credit extensions to the Credit Parties;

WHEREAS, in connection with the Credit Agreement, and pursuant to those certain Trademark Security Agreements, Patent Security Agreements and Copyright Security Agreements described on Annex I attached hereto (collectively, the "Security Agreements"), the Grantors granted to Agent a security interest in certain trademarks, patents and copyrights owned by them, including those listed on Annex I attached hereto (the "Intellectual Property Collateral"); and

WHEREAS, the Security Agreements were recorded in the United States Patent and Trademark Office (the "USPTO") and the United States Copyright Office (the "Copyright Office") on the dates and on the reels and frames as set forth on Annex I hereto.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself and as agent for each other Lender, hereby terminates, releases and discharges without representation, recourse or warranty whatsoever, all of its security interest in and to all of its right, title and interest in the Intellectual Property Collateral (including all goodwill of the business connected with the use of, and symbolized by, all trademarks included in the Intellectual Property Collateral), granted pursuant to the Security Agreements, and Agent hereby retransfers and reassigns any and all such right, title and interest (if any) that Agent may have in the Intellectual Property Collateral to the applicable Grantor. The Agent hereby authorizes and requests that the USPTO record this Release, and Agent hereby authorizes the Grantors to file this Release on behalf of the Agent with the USPTO or any other relevant governmental authority.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
