ASSIGNMENT OF TRADEMARKS

AND

THE UNITED STATES AND FOREIGN REGISTRATIONS THEREOF

WHEREAS, Melton L. Bacon, an individual, doing business as "Coronado Stone Products," having a place of business at 11191 Calabash Street, Fontana, California 92337 ("ASSIGNOR"), acquired, adopted and used, and thereby, owns all rights, title and interests in and to the trademarks and United States and the foreign Registrations thereof, identified in Exhibit A attached hereto and by this reference incorporated herein (the "Marks" and "Registrations," respectively), along with the goodwill of the businesses appurtenant to said Marks; and

WHEREAS, Creative Stone Mfg., Inc., a corporation formed under the laws of the State of California, having a principal place of business at 11191 Calabash Street, Fontana, California 92337 ("ASSIGNEE"), is desirous of acquiring the entire rights, title and interest in and to the Marks and Registrations identified in Exhibit A attached hereto and the goodwill associated with the Marks, and ASSIGNOR is willing to assign the same to ASSIGNEE;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, ASSIGNOR does hereby sell, assign, convey and transfer unto ASSIGNEE, his successors, assigns and legal representatives, the full and entire right, title and interest in and to the Marks and Registrations identified in said Exhibit A, and the attendant goodwill symbolized by the Marks, and any and all other trademarks, service marks and trade names heretofore used by ASSIGNOR anywhere, whether registered or not (said other trademarks, service marks and trade names, if any, being included within the meaning of the term "Marks"), and the attendant goodwill symbolized thereby, the same to vest in ASSIGNEE immediately.

ASSIGNOR hereby represents and warrants that (i) he is the sole owner of the Marks and the goodwill associated therewith and the Registrations relating thereto; (ii) the Registrations thereof were not obtained fraudulently or contrary to any provision of Title 15, Chapter 22 of the United States Code, or any provision of the trademark laws of any foreign jurisdiction; (iii) the United States Registrations thereof are not the subject of any cancellation proceedings in the United States Patent and Trademark Office or in the Trademark Offices of any of the foreign jurisdictions identified in said Exhibit A; (iv) he has granted no licenses to any third party to use the Marks; (v) he is not aware of any third party who has asserted a claim of any ownership right, title and interest in the Marks or the Registrations, or any other rights or interests therein which are adverse to those of ASSIGNOR; and (vi) he is not a party to any prior agreement, nor has he made any informal commitment or reached any understanding with any other person or legal entity relating to the Marks and Registrations which would be breached or otherwise violated by the foregoing assignment of the Marks and Registrations. In this

connection, ASSIGNOR states that he makes no other representations or warranties, expressed or implied, except as specifically set forth herein.

ASSIGNOR hereby agrees that ASSIGNEE shall have the right to record this instrument of assignment with the United States Patent and Trademark Office and with the Trademark Offices in the other countries in which Registrations have been granted, so as to establish ASSIGNEE as owner of record of the Marks and Registrations in the United States and in the foreign jurisdictions identified in said Exhibit A.

ASSIGNOR further agrees, at the request of ASSIGNEE and without charge or cost to ASSIGNEE, to (i) execute and have executed any and all other documents of any kind whatsoever required to carry out the intent of this instrument of assignment; (ii) provide whatever information may be required to carry out the intent of this instrument of assignment; and (iii) fully cooperate with ASSIGNEE, as reasonably required, to enable ASSIGNEE to duly record this instrument of assignment with the United States Patent and Trademark Office and the Trademark Offices in said foreign jurisdictions, whereby ASSIGNEE's ownership of the Marks and Registrations is duly made of record in the United States Patent and Trademark Office and in the Trademark Offices of said foreign jurisdictions.
