RELEASE OF TRADEMARK SECURITY INTEREST

**THIS RELEASE OF TRADEMARK SECURITY INTEREST** (this "Release of Trademark Security Interest") is made as of August 13, 2013 ("Effective Date") by COMPASS GROUP DIVERSIFIED HOLDINGS LLC, a Delaware limited liability company (the "Secured Party") in favor of FOX FACTORY, INC., a California corporation (the "Grantor"). All terms used in this Release of Trademark Security Interest with initial capital letters and not defined herein shall have the respective meanings ascribed to them in the Security Agreement (as defined below).

**WHEREAS**, pursuant to that certain Intellectual Property Security Agreement, dated as of January 4, 2008, between Secured Party and Grantor, as amended by that certain First Amendment to Intellectual Property Security Agreement, dated as of October 25, 2011 (the "Security Agreement"), Grantor granted to Secured Party a continuing security interest in and to the Trademark Collateral.

**WHEREAS**, the Security Agreement was recorded on behalf of Secured Party by the United States Patent and Trademark Office on February 11, 2008 at Reel 3717, Frame 0361 and, as amended, on October 26, 2011 at Reel 4648, Frame 0678.

**NOW, THEREFORE, FOR VALUE RECEIVED**, Secured Party hereby (i) terminates the Security Agreement, and (ii) terminates, cancels and releases any and all security interests Secured Party has against the Trademark Collateral. As used herein, the term "Trademark Collateral" means all of Secured Party's right, title and interest, in, to and under (i) the trademarks and trademark applications listed on Exhibit A hereto, (ii) all renewals thereof, (iii) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect thereto, including without limitation, damages and payments for past or future infringements thereof, (iv) the right to sue for past, present and future infringements thereof, (v) all rights corresponding thereto throughout the world, and (vi) all goodwill of the Grantor's business connected with and symbolized by such trademarks and trademark applications.

The Secured Party represents and warrants that: (i) it has the full power and authority to execute this Release of Trademark Security Interest; and (ii) it has not assigned, transferred, restricted or otherwise encumbered its rights under the Security Agreement.

The Secured Party shall, at Grantor's sole cost and expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this release.
