RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of July 31, 2013 (the "Effective Date") between Connecticut Innovations, Incorporated, a Connecticut corporation (the "Secured Party") and Andrews Consulting Group, Inc., a Connecticut corporation ("ACG") and the Andrews Group LLC, a Connecticut limited liability corporation ("TAG"). ACG and TAG are referred to herein, individually and collectively, and jointly and severally, as the "Debtor."

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement, dated as of June 13, 2012, between the Debtor and the Secured Party (the "Collateral Agreement"), the Debtor pledged, assigned and granted to the Secured Party a continuing security interest in all of their right, title and interest in and to certain collateral including, without limitation, the trademark registrations set forth on Schedule 1 attached hereto, along with the goodwill associated therewith (collectively, the "Trademarks");

WHEREAS, the Secured Party has agreed to release its interest in and to the Trademarks and the following:

(i) The portion of the Collateral Agreement that was recorded with the Trademark Division of the U.S. Patent and Trademark Office on June 14, 2012, at Reel 4804 and Frame 0493 relating to the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby terminates, releases, relinquishes, discharges, cancels, re-pledges, reassigns and releases any and all security interests the Secured Party has against the Trademarks.

If and to the extent the Security Party has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to the Debtor.
