PATENT AND TRADEMARK RELEASE AND REASSIGNMENT

This Patent and Trademark Release and Reassignment is entered into as of August 9, 2013, by Wells Fargo Bank, National Association, a national banking association (the “**Lender**”).

Subject to other security interests, if any, granted by the Borrower to other creditors of the Borrower, the Lender hereby reassigns, grants and conveys to the Borrower, without any representation, warranty, recourse or undertaking by the Lender, all of the Lender’s right, title and interest in and to the Patents and Trademarks, including without limitation the Trademarks set forth on Schedule 1 hereto.

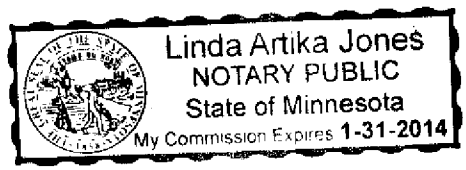


