## ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS

This ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS ("Assignment"), effective as of August 9, 2013 (the "Effective Date"), is entered into by and between AH LAM JUNG, a Florida individual (the "Assignor") and WORLD CHAMPION CENTER INC a Florida corporation (the "Assignee") (hereinafter referred to collectively as the "Parties" or individually as the "Party").

2. The Assignors do hereby irrevocably sell, grant, convey, transfer, and assign unto the Assignee, its successors and assigns, and Assignee hereby accepts from Assignors, all of the Assignors' rights, title and interest in the United States and the world, including without limitation, all federal, state, and worldwide applications and registrations, all other federal, state, foreign, statutory intellectual property rights and moral rights, in and to the Intellectual Property.
3. The Assignor and the Assignee agree, that this Agreement shall continue in perpetuity; the rights assigned to the Assignee are not limited in time or territory.
4. The Assignor expressly agree to promptly execute any other documents or take any other action as may be reasonably necessary to vest, secure, perfect, protect or enforce the rights and interest of the Assignee in and to the Intellectual Property and to effectuate this Assignment. Notwithstanding the foregoing, Assignee shall assume primary responsibility to record its right, title and interest in the Intellectual Property with any applicable government agencies upon execution of this Assignment.
5. This Assignment shall be governed and construed by and enforced in accordance with the internal laws of the State of Florida (without giving effect to principles of conflicts of laws).
6. The statements contained in the recitals of fact set forth above are true and correct and by this reference are incorporated in and made a part of this Assignment.
