RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release") is made as of August 14, 2013, by SALUS CLO 2012-1, LTD. (in such capacity, the "Lender") under the Trademark Security Agreement referred to below, in favor of Namco, LLC (the "Grantor"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS, reference is made to that certain Senior Secured, Super-Priority Debtor-in-Possession Credit Agreement, dated as of March 28, 2013 (as amended, amended and restated, supplemented, restructured or otherwise modified, renewed or replaced from time to time, the "Credit Agreement"), by and between the Grantor, as debtor and debtor-in-possession and borrower, and the Lender, pursuant to which the Lender agreed to make loans to the Grantor upon the terms and subject to the conditions specified in the Credit Agreement;

WHEREAS, in connection with the Credit Agreement and the Security Agreement and DIP Orders related thereto, the Grantor executed that certain Trademark Security Agreement (the "Trademark Security Agreement"), dated as of March 28, 2013, pursuant to which the Grantor granted to the Lender a lien on and security interest in all of its right, title and interest in, to and under all of its Trademarks, including, without limitation, those trademark registrations and applications for registration referred to on Exhibit A hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 4995, Frame 0598 on April 1, 2013; and

WHEREAS, the Lender acknowledges full performance of the Obligations, and accordingly has agreed to release its lien on and security interest in, to and under the Trademarks, and to reconvey any and all rights in the Trademarks granted pursuant to the Trademark Security Agreement to the Grantor.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, receipt of which is hereby acknowledged, the Lender hereby releases all of the Lender's rights in and to the Trademarks granted pursuant to the Trademark Security Agreement, and reconveys to the persons legally entitled thereto all of the Lender's right, title and interest in and to the Trademarks granted pursuant to the Trademark Security Agreement, all without warranty or representation of any kind.

The Lender hereby authorizes the Grantor, or the Grantor's authorized representative to: (a) record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency, and (b) file UCC financing statement terminations with the applicable filing office in order to memorialize the release of the lien on and security interest of the Lender in the Trademarks.

This Release and the rights and obligations of the parties hereunder shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
