TRADEMARK ASSIGNMENT

When requested to carry out in good faith the intent and purpose of this Assignment, Assignor (or its successors, assigns, and/or legal representatives) will execute all renewals, registrations, substitutes, extensions thereof, foreign equivalents thereof, and derivations therefrom relating to the Trademarks, execute all rightful oaths, assignments, powers of attorney and other papers, testify in any legal or quasi legal proceedings, communicate to said Assignee (or its successors, assigns, and/or legal representatives) all facts known to the Assignor (or its successors, assigns, and/or legal representatives) relating to the Trademarks and the history thereof, and generally do everything possible which said Assignee (or its successors, assigns and/or legal representatives) considers desirable for aiding in maintaining and enforcing proper protection for the Trademarks and for vesting title to the Trademarks in said Assignee (or its successors, assigns, and/or legal representatives).

Assignor represents and warrants to Assignee, and its successors, assigns, and legal representatives, that no assignment, grant, mortgage, license, or other agreement affecting the rights and property herein conveyed has been made to others, and that full right to convey the same as expressed herein is possessed by Assignor.


