RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of August 9, 2013 (“Effective Date”) by Antares Capital Corporation as collateral agent for each of the Purchasers (together with its successor(s) thereto in such capacity, the “Collateral Agent”) in favor of Spyder Active Sports, Inc. (“Grantor”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Second Lien Security Agreement (as defined below).

WHEREAS, Grantor and the Collateral Agent entered into that certain Second Lien Security Agreement by and between Grantor, the Collateral Agent and the Purchaser parties thereto dated December 23, 2009 (the “Second Lien Security Agreement”), pursuant to which Grantor executed and delivered that certain Second Lien Trademark Security Agreement dated December 23, 2009 (the “Trademark Security Agreement”);

WHEREAS, pursuant to the Trademark Security Agreement, Grantor granted to and created in favor of the Collateral Agent, for its benefit and the ratable benefit of each of the Purchasers, a continuing Lien on and security interest under the Code in and to the Trademark Collateral (as defined in the Trademark Security Agreement and including those items set forth on Schedule A hereto) (subject only to the superior priority of certain Permitted Liens), whether then existing or thereafter acquired by Grantor, as security for the due and punctual payment and performance of the Obligations in full, whether at stated maturity, by required prepayment, declaration, acceleration, demand or otherwise (including any payment of amounts that would become due but for the operation of the automatic stay under Section 362(a) of the United States Bankruptcy Code (or any successor provision));

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 23, 2009 at Reel 4119/Frame 0274; and

WHEREAS, Collateral Agent Acknowledges full performance of the Grantor’s Obligations and accordingly requests a specific release of the security interest granted and recorded against the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby, on behalf of itself and the Purchasers, and each of their respective successors and assigns, hereby: (i) terminates the Trademark Security Agreement and fully releases and discharges any and all liens, security interests, right, title and interest it may have, in whole or in part, in, to and under the Trademark Collateral, together with the goodwill of the business symbolized thereby, all applications and registrations related thereto, and all other right, title and interest in and to the Trademark Collateral conveyed to Collateral Agent (if any) pursuant to the Second Lien Security Agreement, the Trademark Security Agreement and/or any other agreement; (ii) re-assigns to Grantor any and all such right,

title and interest that it may have in the Trademark Collateral (if any) to Grantor; (iii) agrees that it shall execute all other documents and do all other acts necessary to relinquish and effect the release of such rights to Grantor; and (iv) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of the Collateral Agent's rights under the Second Lien Security Agreement and the Trademark Security Agreement with respect to the Trademark Collateral.


