TRADEMARK ASSIGNMENT AGREEMENT

Assignor hereby acknowledges that it retains no right to use the Trademark and agrees not to challenge, or to assist others to challenge the validity, or Assignee's ownership, of the Trademark. Assignor hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into by Assignor that would conflict with this Agreement.

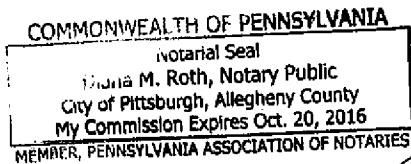
