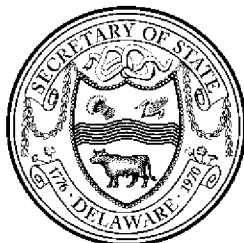

This Certificate of Conversion to Limited Liability Company, dated as of July 29, 2013, has been duly executed and is being filed by TVL Broadcasting, Inc., a Delaware corporation (the "Company"), to convert the Company to TVL Broadcasting LLC (the "LLC") under the Delaware Limited Liability Company Act (6 Del. C. § 18-101, et seq.) (the "DLLCA") and the General Corporation Law of the State of Delaware (8 Del. C. § 101, et seq.) (the "DGCL").

1. The Company filed its original Certificate of Incorporation with the Secretary of State of the State of Delaware and was first incorporated on November 1, 1996, in the State of Delaware, and was incorporated in the State of Delaware immediately prior to the filing of this Certificate of Conversion to Limited Liability Company.
2. The Company's name immediately prior to the filing of this Certificate of Conversion to Limited Liability Company was TVL Broadcasting, Inc.
3. The name of the LLC into which the Company shall be converted as set forth in its Certificate of Formation is TVL Broadcasting LLC, a Delaware limited liability company.
4. The conversion of the Company to the LLC has been approved in accordance with the provisions of Sections 228 and 266 of the DGCL and Section 18-214 of the DLLCA.
5. The conversion of the Company to the LLC is intended to qualify as a liquidation under Section 332 of the Internal Revenue Code of 1986, as amended.
6. The conversion of the Company to the LLC shall be effective upon the filing of this Certificate of Conversion to Limited Liability Company and a Certificate of Formation with the Secretary of State of the State of Delaware.

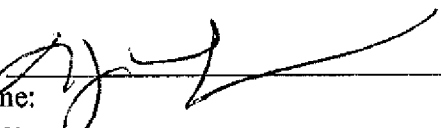
