**NOTICE AND CONFIRMATION OF RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

This NOTICE AND CONFIRMATION OF RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”), effective as of August 16, 2013, is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH (f/k/a Credit Suisse, Cayman Islands Branch), as administrative agent and collateral agent for the Secured Parties (as defined in the Security Agreement referred to below (in such capacities, the “Agent”) in favor of HARLAND FINANCIAL SOLUTIONS, INC., an Oregon corporation (the “Grantor”).

WITNESSETH:

WHEREAS, Harland Clarke Holdings Corp., a Delaware corporation (the “Borrower”), the Grantor and the Agent are each a party to that certain Credit Agreement, dated as of April 4, 2007 (as amended by that certain First Amendment, dated as of May 4, 2007, as further amended by that certain Second Amendment, dated as of May 10, 2012, as further amended by that certain New Facility Joinder Agreement (Tranche B-3 Term Loans), dated as of April 26, 2013, and as may be further amended, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”);

WHEREAS, in connection with the Credit Agreement, the Borrower and the Agent are each a party to that certain Guarantee and Collateral Agreement, dated as of May 1, 2007 (as amended by that certain Amendment Agreement dated as of May 10, 2012, as further amended by that certain Second Amendment, dated as of February 20, 2013, and as may be further amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) pursuant to which the Grantor granted the Agent a security interest in all of the Grantor’s right, title and interest in and to the Released Assets (as defined below);

WHEREAS, pursuant to the Credit Agreement and the Security Agreement, the Grantor has executed and delivered that (x) certain Intellectual Property Security Agreement, dated as of May 1, 2007, which, with respect to certain intellectual property owned by Grantor as of the date hereof, was recorded with the United States Patent and Trademark Office (the “PTO”) at (i) Reel 003542, Frame 0674 as of May 15, 2007, (ii) Reel 019297, Frame 0106 as of May 15, 2007 (iii) Reel 003542, Frame 0707 as of May 15, 2007, (iv) Reel 003808, Frame 0910 as of July 2, 2008, and (v) Reel 003542, Frame 0611 as of May 15, 2007, and with the United States Copyright Office (the “USCO”) at Volume 3552, Document 336 as of May 16, 2007, and (y) certain Supplemental Intellectual Property Security Agreement, dated as of May 9, 2012, which, with respect to certain intellectual property owned by Grantor as of the date hereof, was recorded with the PTO at (i) Reel 004776, Frame 0279 as of May 9, 2012, (ii) Reel 028185 Frame 0139 as of May 9, 2012, and (iii) Reel 004776, Frame 0240 as of May 9, 2012, and with the USCO at Volume 3615, Document 656, as of May 14, 2012;

WHEREAS, as of December 10, 2007, HFS Core Systems, Inc. merged with and into the Grantor;

WHEREAS, Harland Clarke Corp. assigned to Grantor Reg. No. 2,602,265 as of February 19, 2010 and Reg. Nos. 4,235,123 and 4,339,469 as of June 6, 2013, which, for the

avoidance of doubt, is the only intellectual property recorded against at Reel 003542, Frame 0611 and at Reel 004776, Frame 0240 that is covered by this Release; and

WHEREAS, in connection with the Borrower's sale of the Grantor, the Grantor will cease to be a Subsidiary (as such term is defined in the Credit Agreement), and pursuant to that certain Release made by and between the Borrower and the Agent, dated as of August 16, 2013 (the "Release Letter"), the Agent has released its security interest in the Released Assets.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent hereby agrees as follows:

SECTION 1. Release of Security Interest. The Agent hereby confirms that, pursuant to the Release Letter, it has released its security interest in all of Grantor's right, title and interest in and to each of the following (collectively, the "Released Assets"), without recourse to or warranty by the Agent or any Secured Party:

- (a) (i) all United States, State and foreign trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, domain names, logos and other source or business identifiers, whether registered or unregistered, all registrations and recordings thereof, and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country, union of countries, or any political subdivision of any of the foregoing, or otherwise, and all common-law rights related thereto, including the registrations and applications listed on Schedule A attached hereto except for "intent-to-use" applications for trademark or service mark registrations filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, unless and until an Amendment to Allege Use or a Statement of Use under Section 1(c) or Section 1(d) of the Lanham Act has been filed, to the extent that any assignment of an "intent-to-use" application prior to such filing would violate the Lanham Act or cause the trademark that is the subject thereof to be invalidated or abandoned, (ii) all renewals thereof and the right to obtain all renewals thereof, (iii) the right to sue or otherwise recover for past, present and future infringements or dilutions of any of the foregoing or for any injury to goodwill, (iv) all proceeds of the foregoing, including all royalties, income, payments, claims, damages and proceeds of suit now and hereafter due and/or payable with respect thereto, including payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements or dilutions thereof, and (v) all other rights of any kind whatsoever accruing thereunder or pertaining thereto throughout the world, together in each case with the goodwill of the business connected with the use of, and symbolized by, each of the above;
- (b) (i) all patents of the United States, any other country, or union of countries or any political subdivision of any of the foregoing, and all applications in connection therewith, including all patents and patent applications in the

United States Patent and Trademark Office (including those listed on Schedule B attached hereto), (ii) all reissues, extensions, divisions, continuations and continuations-in-part thereof, and the right to obtain all reissues and extensions thereof, (iii) all inventions (whether or not patentable) and all improvements thereof, (iv) the right to sue or otherwise recover for past, present and future infringements of any of the foregoing, (v) all proceeds of the foregoing, including all royalties, income, payments, claims, damages and proceeds of suit now and hereafter due and/or payable with respect thereto (including payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof), and (vi) all other rights of any kind whatsoever accruing thereunder or pertaining thereto throughout the world;

- (c) (i) all copyrights arising under the laws of the United States, any other country, or union of countries, or any political subdivision of any of the foregoing, whether registered or unregistered and whether or not the underlying works of authorship have been published, all registrations and recordings thereof, and all applications in connection therewith, including all registrations, recordings and applications in the United States Copyright Office (including those registrations and applications listed on Schedule C attached hereto), (ii) all extensions and renewals thereof, and the right to obtain all extensions and renewals thereof, (iii) the right to sue or otherwise recover for past, present and future infringements of any of the foregoing, (iv) all proceeds of the foregoing, including all royalties, income, payments, claims, damages, and proceeds of suit now or hereafter due and/or payable with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith, and damages or payments for past, present or future infringements thereof, and (v) all other rights of any kind whatsoever accruing thereunder or pertaining thereto throughout the world; and
- (d) solely to the extent that the Grantor has recorded its interest therein with the United States Copyright Office or the United States Patent and Trademark Office, exclusive Trademark Licenses, exclusive Patent Licenses and exclusive Copyright Licenses, including those agreements listed on Schedule D attached hereto, and all rights to sue or otherwise recover at law or in equity for any past, present and future infringement, misappropriation, dilution or other impairment thereof, including the right to receive all proceeds and damages therefrom.

SECTION 3. Governing Law. This Release shall be deemed to be a contract made under and governed by the laws of the state of New York, without regard to its conflicts of law provisions.




Grantor all releases or other documents reasonably necessary or desirable for the release of the Liens (as such term is defined in the Credit Agreement) on the Released Assets.
