TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT ("*Assignment*"), dated August 16, 2013, is entered into by and between Filebanc, LP, a Texas limited partnership having a principal place of business at 1250 Wood Branch Park Drive, Suite 625, Houston, Texas 77079 ("*Assignor*") and j2 Global, Inc., a corporation of Delaware, with a principal place of business at 6922 Hollywood Blvd., 5th Floor, Hollywood, California 90028 ("*Assignee*"), each individually referred to as a "Party" and collectively referred to as the "Parties."

WHEREAS, Assignor is the owner of the common law trademarks, registered trademarks, applications to register trademarks, and other registrations or applications related to the trademarks listed on Schedule I, attached hereto (the "*Assigned Marks*").

WHEREAS, Assignee is desirous of acquiring the full right, title and interest in, to and under the Assigned Marks and the goodwill accrued in connection and associated therewith.

NOW, THEREFORE, in consideration of the foregoing and the mutual promises, covenants and conditions contained herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereto, intending to be legally bound, hereby agree as follows:

Section 1. Assignment. Assignor does hereby assign, transfer, convey and set over unto Assignee its full right, title and interest, including common law rights, in the United States of America, and in all countries and jurisdictions of the world, in, to and under the Assigned Marks and any other common law trademarks, together with the goodwill of the business symbolized by said Assigned Marks and any other common law trademarks, and applications and registrations thereof, any renewal rights therein, and the exclusive right to enforce the Assigned Marks in the United States and throughout the world in the sole name of Assignee, its successors and assigns; the aforesaid transferred rights, title and interests to be held and enjoyed by Assignee, its successors, legal representatives and assigns as fully and entirely as the same would have been held and enjoyed by Assignor had this assignment not been made.
