# Trademark Assignment

(Nunc Pro Tunc)

This Trademark Assignment (the "Assignment"), is between Sugarland Properties Incorporated (the "Assignor"), a Texas corporation, and First Colony Community Association (the "Assignee"), a Delaware corporation.

## Premises

Assignor was the owner of all right, title, and interest in the mark FIRST COLONY (the "Trademark", having U.S Registration No. 3,323,420), which has been used, and is still being used, as both a trademark for newsletters in the field of community deed restriction compliance issues, and community sporting and cultural events, and as a service mark for organizing community sporting and cultural events.

Assignor has already verbally assigned the Trademark to Assignee, and, by this document, desires and intends to document the assignment (*nunc pro tunc*) to Assignee of the Trademark and all other rights owned by Assignor in the Trademark.

Assignee desires to acquire the Trademark and all other rights owned by Assignor in the Trademark.

## Grant

In consideration of the premises, mutual covenants, and agreements contained in this assignment, and other good and valuable consideration, the receipt and sufficiency of which are acknowledged, Assignor assigns to Assignee the entire right, title, and interest to the Trademark, including without limitation, all associated registrations and trademark applications, together with the goodwill of the business symbolized by the Trademark, and the right to sue for and collect damages for past infringements of the Trademark.

Assignor shall deliver to Assignee all files in its possession or in possession of its agents concerning the Trademark, including all trademark prosecution, opposition, cancellation, and enforcement files.

Assignor covenants that it has the full right to convey the entire right, title, and interest in the Trademark, and that it has not executed, and will not execute, any conflicting agreement. Assignor further covenants that it will sign all lawful papers, make all rightful declarations and/or oaths, and generally do what is necessary to enable Assignee, its successors, legal representatives, and assigns, to record and enforce this Assignment, and protect and enforce the Trademark in all countries.

This Assignment may be executed in any number of counterparts, and each counterpart hereof shall be deemed to be an original instrument, but all such counterparts shall constitute but one Assignment.

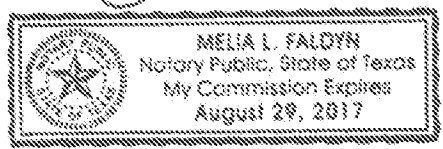
