ASSIGNMENT OF TRADE MARKS AND DOMAIN NAME

THIS ASSIGNMENT IS DATED EFFECTIVE the 8<sup>th</sup> day of February 2013

BETWEEN

(1) COMPSOFT PLC, a company (registration number 02478435) organized and existing under the laws of England and Wales and having its registered office at Delta House, 7 Oriel Court, Omega Park, Alton, Hampshire GU34 2YT, United Kingdom (hereinafter "the Assignor")

AND

(2) IPRESENT LIMITED, a company (registration number 08048599) organized and existing under the laws of England and Wales and having its registered office at Delta House, 7 Oriel Court, Omega Park, Alton, Hampshire GU34 2YT, United Kingdom (hereinafter "the Assignee");

WHEREAS

(1) The Assignor is the proprietor, or applicant, and owner of the registered and pending trade marks and domain name as set out in Schedule 1 hereto (hereinafter "the Trade Marks and Domain Name"),

(2) By virtue of an Agreement entered into by the parties hereto and dated simultaneously herewith it is agreed by the parties that the Trade Marks and Domain Name shall be assigned from the Assignor to the Assignee upon the terms hereinafter set forth;

NOW THIS ASSIGNMENT WITNESSETH THAT

1. In consideration of the sum of £1 (one pound sterling) paid by the Assignee to the Assignor, the receipt and sufficiency of which the Assignor hereby acknowledges, the Assignor hereby irrevocably and exclusively grants, assigns, transfers, and conveys to the Assignee all right, title, interest and ownership in and to the Trade Marks and Domain Name, including without limitation any and all statutory and common law rights in and to the Trade Marks and Domain Name throughout the world, including the right to sue and recover damages for past infringement, and including the right to claim

priority under the Paris Convention in any and all countries of the world from any registration or application for any of the trade marks of the Trade Marks, and including the goodwill attaching to the Trade Marks and Domain Name and including the goodwill in that part of the business of the Assignor connected with the use of and symbolized by the Trade Marks and Domain Name and in connection with which the Trade Marks and Domain Name have been used by the Assignor to hold the same unto the Assignee absolutely.

2. This Assignment shall be effective and binding upon the heirs, assigns, representatives and successors of the parties hereto and shall extend to the successors, assigns and nominees of the Assignee.

3. The Assignor hereby agrees to do or procure all else that may be necessary including executing any and all further documents as the Assignee may at any time reasonably require in order to vest full ownership and title in and to the Trade Marks and Domain Name in the Assignee.

4. This Assignment shall be governed by and construed in accordance with the laws of England and Wales.

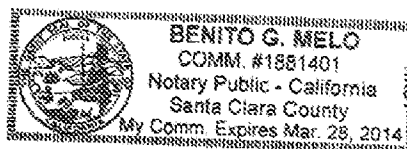

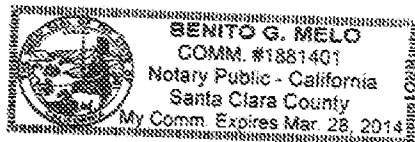
