ASSIGNMENT OF MARKS

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made effective the 11th day of January, 2011, by e-TYMS, L.C., a Missouri limited liability company ("ASSIGNOR"), to Jack Cooper Transport Company, Inc., a Delaware corporation ("ASSIGNEE");

Section 1

ASSIGNMENT

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR's right, title, and interest in and to the Marks, together with (1) the goodwill of the business relating to the Goods in respect of which the Marks are used; (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Marks, including without limitation damages and payments for past or future infringements and misappropriations of the Marks; and (3) all rights to sue for past, present, and future infringements or misappropriations of the Marks.

Section 2

FURTHER ASSURANCES

ASSIGNOR further covenants that it will execute all documents, papers, forms, and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Marks.

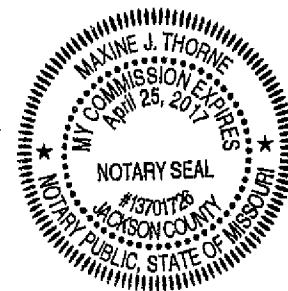
