AND ASSIGNOR HEREBY covenants that it has full right to convey the entire interest herein assigned, and has not executed, and will not execute, any agreement in conflict herewith;

AND ASSIGNOR HEREBY further covenants and agrees that it will sign all lawful papers and make all rightful oaths as reasonably required to evidence the transfer and assignment of rights in the Marks to Assignee as set forth herein.


