RELEASE AND REASSIGNMENT OF TRADEMARKS (SECOND LIEN)

THIS RELEASE AND REASSIGNMENT OF TRADEMARKS dated August 15, 2013 by AMP ADMIN LLC, a Delaware limited liability company (“AMP”) as successor administrative agent to EMPORIA CAPITAL FUNDING LLC , with its mailing address at 245 Park Avenue, 43rd Floor, New York, New York 10167, acting as administrative agent hereunder for the Lenders as defined in the Security Agreement referred to below (AMP acting as such administrative agent being hereinafter referred to as the “Administrative Agent”);

WITNESSETH:

WHEREAS, River Point Farms, LLC, a Texas limited liability company, with its mailing address at 500 Crescent Court, Suite 250, Dallas, Texas 75201, (the “Grantor”), American Onion International, Inc., a Nevada corporation, and the Administrative Agent are parties to a certain Second Lien Security Agreement dated April 13, 2007, which was recorded in the United States Patent and Trademark Office on September 26, 2007 at Reel 003629, Frame 0118 (the “Security Agreement”), pursuant to which the Grantor granted to the Administrative Agent, a security interest in and collateral assignment of, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule 1 attached hereto and certain other property (collectively, the “Trademark Collateral”); and

The Administrative Agent hereby releases its security interests in and collateral assignment of, and reassigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by the Administrative Agent, all of its right, title and interest, if any, in and to each trademark, trademark registration, and trademark application listed on Schedule 1 hereto, and all present and future, trademarks, trade names, trade styles, service marks, all prints and labels on which said trademarks, trade names, trade styles and service marks appear, have appeared, or will appear, and all designs and general intangibles of a like nature, all applications, registrations, and recordings relating to any of the foregoing in the United States Patent and Trademark Office or in any similar office or agency of the United States of America, any state thereof, or any political subdivision thereof, or in any other countries, and all reissues, extensions, and renewals thereof, including without limitation, those registered and applied-for trademarks, terms, designs and applications described on Schedule 1 hereto, and the goodwill of the business symbolized by each Trademark Collateral, including, without limitation, all customer lists and other records relating to the distribution of products or services bearing the Trademark Collateral.
