PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Partial Release") is made as of August 28, 2013 ("Effective Date") by **Toronto Dominion (Texas) LLC**, as administrative agent, a Delaware limited liability company ("Agent"), in favor of **Intelicoat Technologies Image Products Holdco, LLC**, a Delaware limited liability company ("Intelicoat").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement executed by Crane & Co., Inc. ("Grantor") in favor of the Agent dated December 22, 2008 (the "Trademark Security Agreement"), Grantor granted to the Agent a continuing security interest in and to all of its right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the trademark registrations set forth on Schedule 1 attached hereto (the "Specified Marks");

WHEREAS, pursuant to that certain Assignment Agreement by and between Grantor and Intelicoat dated December 14, 2007 (the "Trademark Assignment"), Grantor assigned the entire interest in and goodwill associated with the Specified Marks to Intelicoat;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (the "PTO") on February 10, 2009, at Reel/Frame 3933/0579; and

WHEREAS, the Trademark Assignment was recorded with the PTO on April 13, 2011 at Reel/Frame 4521/0201.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates, cancels and releases any and all security interests it has in the Specified Marks.

Nothing herein is, or shall be deemed, a termination, cancellation, release or other modification of the Agent's security interests or liens in any other asset of Grantor.
