**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

WHEREAS **Allen-Vanguard Technologies Inc.**, a Canadian corporation, **Vanguard Response Systems (UK) Limited**, a United Kingdom company, **P W Allen Holdings Limited**, a United Kingdom company, **Allen-Vanguard Ltd.**, a United Kingdom company, and **Hazard Management Solutions Limited**, a United Kingdom company (together, the "Grantors"), entered into that certain security agreement dated December 18, 2009 (the "Security Agreement") with **Contego AV Luxembourg S.A. R.L.**, a Luxembourg *societe a responsabilite limitee* ("Contego"), notice of which was recorded January 6, 2010 at the United States Patent and Trademark Office at Reel 4125, Frame 0328.

WHEREAS, Grantors granted Contego, under the terms of the Security Agreement, a continuing security interest (the "Security Interest") in favor of Contego in and to certain of Grantors' intellectual property, including without limitation the trademarks listed in Schedule A (collectively, the "Trademarks") and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks.

WHEREAS, Contego has terminated and released its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, Contego hereby releases all liens and the Security Interest, hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to Grantors and its successors and assigns in association with the Security Interest, and hereby releases Grantors and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
