ASSIGNMENT OF TRADEMARK

WHEREAS, EBSCO Industries, Inc., a Delaware corporation with a principal place of business at 5724 Highway 280 East, Birmingham AL 35242 ("EBSCO") has adopted, used and is using and is the owner of U.S. Trademark 3,568,404 for "BIG WATER ADVENTURES" (hereinafter the "Trademark");
