## RELEASE OF TRADEMARK GRANT OF SECURITY

This RELEASE OF TRADEMARK GRANT OF SECURITY (this "Release"), is made effective as of August 26, 2013 by and from WELLS FARGO BANK, NATIONAL ASSOCIATION (the "Bank"), in favor of KINEDYNE CORPORATION, a Delaware corporation (the "Debtor").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank agrees as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release have the meanings provided in the Security Agreement.


SECTION 2. Release of Security Interest. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby assigns to and releases the Debtor from the security interest in and continuing lien on all of the Debtor's right, title and interest in, to and under the Trademarks, including, without limitation, the Trademarks listed on Exhibit A of the Security Agreement.

SECTION 3. Release of the Security Agreement. This Release has been executed and delivered by the Bank for the purpose of releasing the security interest of the Bank in the Trademarks in the United States Patent and Trademark Office and worldwide.
