ASSIGNMENT AGREEMENT

Assignment Agreement dated as of April 14, 2011, between Jeffrey D. 2. Assignor hereby grants to Assignee a specific power of attorney and authority to act on behalf of and in the name of Assignor to execute all documents and to perform all acts that are necessary to perfect and record the assignment of the Trademark.
3. In consideration for the Assignment, the Assignee hereby issues to the Assignor a membership interest in the Assignee as reflected in Schedule A to the Limited Liability Company Agreement of Assignee dated April 14, 2011.
