THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of August 30, 2013, by **BANK OF AMERICA, N.A.**, as Administrative Agent (“**Administrative Agent**”).

WITNESSETH:

WHEREAS, Administrative Agent and Joint Juice Acquisition Sub Inc. (n/k/a Premier Protein, Inc. NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


1. Administrative Agent hereby releases and discharges fully its security interest in and lien on all of Obligor’s right, title and interest in and to the Trademarks; and
