## TRADEMARK ASSIGNMENT

WHEREAS, Assignee desires to own all right, title and interest in and to the Trademarks.


NOW THEREFORE, for good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignment. Assignor hereby assigns, transfers and otherwise conveys to Assignee the entire right, title, interest in and to the Trademarks in the United States and all jurisdictions outside the United States, together with the goodwill of the business connected with and symbolized by the Trademarks (including, without limitation, the right to renew any registrations included in the Trademarks, the right to apply for trademark or domain name registrations within or outside the United States based in whole or in part upon the Trademarks, and any priority right that may arise from the Trademarks), the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this assignment, transfer and conveyance not been made. To the knowledge of Assignor, the Trademarks do not infringe on the rights of another person.
2. Further Assurances. Assignor agrees to execute and deliver at a future date any additional documents that Assignee reasonably determines are required to perfect Assignee's ownership of or title to the Trademarks.
3. Successors and Assigns. This trademark assignment is binding on Assignor and its respective successors and assigns, and inures to the benefit of Assignee and its successors and assigns.
