## RELEASE OF SECURITY INTEREST IN PATENTS, TRADEMARKS AND LICENSES

This Release of Security Interest in Patents, Trademarks and Licenses (this "Release") is made as of September 1, 2013 (the "Effective Date"), by The CIT Group/Commercial Services, Inc. ("CIT"), in favor of Blue Vintage LLC ("Blue Vintage").

WHEREAS, pursuant to the terms and conditions of the Grant of Security Interest in Patents, Trademarks and Licenses dated February 23, 2009, between CIT and Blue Vintage (the "Security Agreement"), Blue Vintage granted to CIT a continuing security interest in all of its right, title, and interest in and to certain property as defined in the Security Agreement (the "Intellectual Property Collateral"), including the trademark registrations set forth on Schedule 1 hereto, along with the goodwill associated therewith;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on March 3, 2009, on Reel/Frame 003945/0425; and

WHEREAS, CIT desires to release terminate, discharge, and convey its security interest in and to the Intellectual Property Collateral and grant all of its right, title, and interest in and to the Intellectual Property Collateral to Blue Vintage;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:


1. CIT hereby terminates the Security Agreement and releases, terminates, discharges, reassigns, and conveys to Blue Vintage any and all security interests in, and any other right, title, or interest of any kind or nature in, to, or under the Intellectual Property Collateral, including without limitation the trademark registrations listed on Schedule 1 attached hereto.

2. CIT hereby authorizes and acknowledges the termination of the Security Agreement. At Blue Vintage's expense, CIT hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby and terminate the Security Agreement.

3. This Release shall be governed by, and construed in accordance with, the laws of the State of California, without reference to its choice of law rules that would result in the application of the laws of another jurisdiction.
