## TRADEMARK SECURITY AGREEMENT

**Trademark Security Agreement**, dated as of August 22, 2013, by Bombardier Recreational Products Inc. (the "Pledgor"), in favor of Bank of Montreal, in its capacity as administrative agent (in such capacity, the "Administrative Agent") pursuant to the Amended and Restated Revolving Credit Agreement, dated as of June 28, 2006, as amended and restated as of March 19, 2012 (the "Revolving Credit Agreement") and as further amended by Amendment No.1, dated as of January 30, 2013, and Amendment No. 2, dated as of May 30, 2013 ("Amendment No. 2") by and among the Pledgor, BRP US Inc., the Guarantors listed on the signature pages thereof, the Lenders listed on the signature pages thereof, and the Administrative Agent.

WITNESSETH:

WHEREAS, the Pledgor is party to that certain Amended and Restated Canadian Revolving Security Agreement (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), dated as of March 19, 2012, in favor of the Administrative Agent pursuant to which the Pledgor is required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Administrative Agent, for the benefit of the Secured Parties, to enter into the Amendment No.2, the Pledgor hereby agrees with the Administrative Agent as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

SECTION 2. Grant of Security Interest in Trademark Collateral. The Pledgor hereby pledges and grants to the Administrative Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under all of the following Pledged Collateral of the Pledgor:

- (a) Trademarks of such Pledgor listed on Schedule I attached hereto;
- (b) all Goodwill associated with such Trademarks; and
- (c) all Proceeds of any and all of the foregoing (other than Excluded Property).

SECTION 3. Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Administrative Agent pursuant to the Security Agreement and Pledgor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademarks made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control unless the Administrative Agent shall otherwise determine. The security interest granted pursuant to this Trademark Security Agreement shall be subject to the terms of the Intercreditor Agreement.

SECTION 4. Termination. Upon the payment in full of the Obligations and termination of the Security Agreement, the Administrative Agent shall execute, acknowledge, and deliver to the Pledgor an instrument in writing in recordable form releasing the collateral pledge, grant, assignment, lien and security interest in the Trademarks under this Trademark Security Agreement.


SECTION 5. Counterparts. This Trademark Security Agreement may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party here-




