**TERMINATION AND RELEASE OF TRADEMARK
SECURITY AGREEMENT**

This Termination and Release of Trademark Security Agreement (the "Release") is conveyed as of August 28, 2013, by SUSQUEHANNA BANK under the Security Agreement referred to below ("Susquehanna"), in favor of CORPORATE TRAINING TECHNOLOGIES, LLC, formerly known as CTT OPS SUB, LLC, a Delaware limited liability company ("CTT").

WHEREAS, reference is made to that certain Trademark Security Agreement, dated as of January 21, 2009 (as amended, amended and restated, or otherwise modified to the date hereof, the "Security Agreement"), by and among CTT, the other Obligors party thereto, and Susquehanna.

WHEREAS, the records of the United States Patent and Trademark Office reflect that Susquehanna and CTT entered into the Security Agreement, under which CTT granted to Susquehanna a security interest in CTT's interest in the trademark and trademark applications, including, without limitation the trademark and trademark applications listed on the attached Schedule A (collectively, the "Trademarks").

WHEREAS, Susquehanna seeks to make a record of Susquehanna's release to CTT of the security interest granted in the Trademarks by CTT in favor of Susquehanna pursuant to the Security Agreement.


