ASSIGNOR agrees to provide ASSIGNEE with any physical and/or electronic files ASSIGNOR has in its possession related to the Marks within 45 days of closing. ASSIGNOR also agrees to execute any further documents necessary to transfer ownership of the Marks to ASSIGNEE.
