**U.S. TRADEMARK ASSIGNMENT**

THIS TRADEMARK ASSIGNMENT (this "Assignment") dated as of September 5, 2013, is made by and among FTS International Services, LLC a Texas limited liability company ("Assignor"), FML Sand, LLC, an Ohio limited liability company ("FML Sand") and FML Resin, LLC, an Ohio limited liability company ("FML Resin", together with FML Sand, the "Assignees", each an "Assignee").

WHEREAS, Assignor and certain of its affiliates and Assignees' parent, Fairmount Minerals, Inc. ("Fairmount") are parties to that certain Asset Purchase Agreement, dated as of July 23, 2013 (the "Purchase Agreement"), according to which Assignor sold, conveyed, transferred, assigned and delivered to Fairmount and certain of its subsidiaries, including the Assignees, certain assets including the U.S. registered trademarks (and any goodwill with respect thereto) and the title thereto set forth on Schedule A (the "U.S. Trademarks");

WHEREAS, the parties desire to execute this Assignment for filing with the United States Patent and Trademark Office.

NOW, THEREFORE, for the good and valuable consideration recited in the Purchase Agreement, the receipt of which is hereby acknowledged, and in fulfillment of its obligations under the Purchase Agreement:

Assignor hereby irrevocably sells, conveys, transfers, assigns and delivers to FML Sand and FML Resin, respectively, all of Assignor's right, title, and interest in and to the U.S. Trademarks designated next to such Assignee in Schedule A and all registrations, applications therefor and renewals and extensions of the foregoing in the United States that are or may be secured under the laws of the United States, now or hereafter in effect, for each Assignee's own use and enjoyment, and for the use and enjoyment of each Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made, together with any income, royalties or payments due or payable as of the date hereof or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the U.S. Trademarks, with the right to sue for and collect the same for such Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.






