WHEREAS, Assignor wishes to execute this Assignment to transfer all of its rights in and to the Trademark and the good will associated therewith to Assignee;


WHEREAS, Assignee wishes to acquire all of Assignor's rights in and to the Trademark and the good will associated therewith;
