## ASSIGNMENT AND ASSUMPTION (INTELLECTUAL PROPERTY)

Reference is made to that certain Second Amended and Restated Trademark Collateral Assignment (as amended, supplemented or otherwise modified from time to time, the “Assignment”), dated as of December 14, 2005, among Pinnacle Entertainment, Inc. and certain of its subsidiaries signatory thereto, collectively, the “Grantors” under and as defined therein, and Barclays Bank PLC, as the “Administrative Agent” (hereafter, “Existing Agent”). Unless otherwise defined herein, terms defined in the Second Amended and Restated Credit Agreement dated as of December 14, 2005 (as amended to the date hereof, the “Existing Credit Agreement”), and used herein shall have the meanings given to them in the Existing Credit Agreement.

WHEREAS, pursuant to the Assignment, the Grantors granted Barclays Bank PLC a security interest in and to all of its right, title and interest in and to all of its Trademarks, including all goodwill associated with such Trademarks, and recorded with the U.S. Patent and Trademark Office as follows:

JPMorgan Chase Bank, N.A. has succeeded to all of the Existing Agent's rights and obligations as the "Administrative Agent", and the parties are executing this Assignment and Assumption to further evidence such succession with respect to the "Collateral" under and as defined in the Assignment.

Accordingly, effective as of August 13, 2013, the Existing Agent hereby irrevocably assigns, without recourse, to JPMorgan Chase Bank, N.A. as successor "Administrative Agent" (in such role, the "Successor Agent"), and Successor Agent hereby

assumes, all of Existing Agent's rights and obligations as the "Administrative Agent" with respect to the Assignment, including, but not limited to, the security interest granted in the trademarks under the Assignments recorded with the U.S. Patent and Trademark Office as noted above.

From and after the Effective Date, (a) the Successor Agent shall be a party to the Assignment and have the rights and obligations of the Administrative Agent thereunder and shall be bound by the provisions thereof, and (b) the Existing Agent shall relinquish its rights and be released from its obligations under the Assignment.

This Assignment and Assumption shall be governed by and construed in accordance with the laws of the State of New York.
