ASSIGNMENT OF TRADEMARK

WHEREAS, the Parties wish to effectuate this transfer in a document suitable for recordation with the U.S. Patent and Trademark Office, and other government agencies.

NOW, THEREFORE, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which Assignor hereby acknowledges, Assignor does hereby sell, assign and transfer to Assignee any and all of its right, title and interest throughout the world in and to the Trademark, together with the goodwill of the business symbolized thereby. Assignor further agrees to execute such further documents as may be

necessary to effectuate the transfer and recordation of the rights transferred hereby anywhere in the world.



