THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination"), is dated as of September 6, 2013, and made by Bank of America, N.A., as administrative agent, having an office at 100 Federal Street, 7th Floor, Boston, Massachusetts 02110 ("BOA") to A.T.X. International, Inc., a Rhode Island corporation, whose principal place of business is One Albion Road, Lincoln, Rhode Island 02865 ("Grantor").

WHEREAS, certain security interests (the "Interests") were granted by the Grantor to BOA in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Interests were recorded in the Assignment Division of the United States Patent and Trademark Office on February 24, 2006, at Reel 3253 and Frame 0261;

WHEREAS, BOA now desires to terminate and release the Interests; and

NOW, THEREFORE, for good and valuable consideration, BOA hereby states as follows:


