RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release"), dated as of September 6, 2013, is entered into by and between Venture Lending & Leasing V, Inc. and Venture Lending & Leasing VI, Inc., both Maryland corporations (together as "Assignor") in favor of WeddingWire, Inc., a Delaware corporation ("Assignee").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of November 24, 2010, among the Assignee and Assignor, Assignee granted a security interest to the Assignor in certain collateral, including the Trademarks set forth on Schedule A;

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on December 20, 2010 at Reel 4436, Frame 0510;

WHEREAS, Assignee granted to Assignor a security interest in all of Assignee's right, title, and interest in, to and under the Trademarks, whether then owned or existing or at any time hereafter acquired or arising or wherever located, as collateral security for the prompt and complete payment and performance when due of Assignee's obligations. For purposes of this release and the Trademark Security Agreement, "Trademarks" means all trademarks, trade names, corporate names, company names, business names, service marks, logos, and all goodwill associated therewith, then existing or thereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, and all common-law rights, related thereto, including, without limitation, any of the foregoing referred to on Schedule A, and the right to obtain all renewals thereof; and

WHEREAS, Assignor has agreed to terminate and release its security interest and all of its right, title and interest in each of the Trademarks.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor and Assignee hereby agree as follows:


Assignor hereby releases and discharges its security interest in all of Assignee's right, title and interest in and to the Trademarks, including, but not limited to the Trademarks listed on Schedule A hereto, and reassigns and transfers any and all interest that Assignor may have in the Trademarks to Assignee.

Assignor hereby authorizes Assignee or Assignee's authorized representative to file this release with the United States Patent and Trademark Office, file form UCC-3 termination statements, or file this release in the applicable government office or agency.

Assignor further agrees to execute and deliver to Assignee any and all further documents and instruments, and do any and all further acts which Assignee (or its agents or designees) reasonably request (at Assignee's sole cost and expense) in order to confirm this release and Assignee's right, title, and interest in or to the Trademarks.


