**TERMINATION AND RELEASE OF THE

This Termination and Release of the Intellectual Property Security Agreement (this "Termination") is executed by Comerica Bank, ("Comerica") in favor of spigit, Inc. a Delaware corporation (the "Grantor").

R E C I T A L S

A. WHEREAS, reference is hereby made to the Intellectual Property Security Agreement, dated as of December 23, 2010, and the Supplemental Intellectual Property Security Agreement, dated as of September 13, 2011 (as amended, modified, renewed or extended from time to time, the "Security Agreement"), between Grantor and Comerica, pursuant to which the Grantor granted to Comerica a security interest in certain of Grantor's present and future assets, including the patents and trademarks identified on Schedule A attached hereto, to secure the obligations owed by Grantor to Comerica;

B. WHEREAS, the Security Agreement was filed with the Patent Division of the United States Patent and Trademark Office on December 29, 2010, at Reel No. 025571 at Frame No. 0019, to evidence the security interest granted under the Security Agreement;

C. WHEREAS, the Security Agreement was filed with the Trademark Division of the United States Patent and Trademark Office on September 14, 2011, at Reel No. 4622 at Frame No. 0331, to evidence the security interest granted under the Security Agreement;

D. WHEREAS, Comerica has agreed to terminate and release its security interest in Grantor's patents and trademarks, including, without limitation, the patents and trademarks identified on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Comerica hereby terminates and releases its security interest in all of the Grantor's patents and trademarks including, without limitation, those referred to on Schedule A hereto, and all proceeds of the foregoing.
