## CONFIRMATORY TRADEMARK ASSIGNMENT

This CONFIRMATORY TRADEMARK ASSIGNMENT (herein after "Assignment") confirms that in a document titled "ASSIGNMENT AND ASSUMPTION AGREEMENT (VESPER CORP/INDUSTRIAL)", which was made and entered into on January 26, 2006, Vesper Corporation ( hereinafter sometimes referred to as "Assignor") assigned its rights to various assets, including the trademark PENCO and design and U.S. Registration No. 1,250,921 for that trademark, to Industrial Manufacturing Company LLC, a Delaware limited liability company ("Assignee").

This agreement confirms that Assignor transferred, assigned, conveyed and delivered to Assignee, and Assignee accepted and acquired from Assignor, all of Assignor's right, title and interest in and to numerous assets, including the trademark PENCO and design and U.S. Registration No. 1,250,921, for that trademark, which issued on September 13, 1983 (herein after collective referred to as "the Penco Trademark Rights").

Vesper Corporation merged into Vesper LLC, a Pennsylvania limited liability company, on January 27, 2006, and therefore ceased to exist as a separate entity under the Vesper Corporation name.

Confirmation of the trademark assignment is being made by Nancy Lenhart, the assistant secretary of Vesper Corporation at the time of the Assignment of the Penco Trademark Rights to Assignee.
