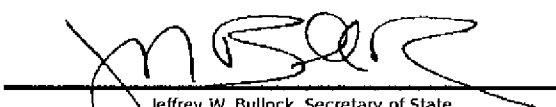

THIRD: The name of the surviving corporation is Smith International, Inc.

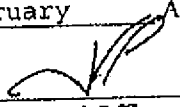
FOURTH: The merger is to become effective on March 1, 2012.
