RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS is made as of September 12, 2013, by TRISTATE CAPITAL BANK (“Bank”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, SOFTWRITERS, INC., a Delaware corporation, (“Grantor”) and Bank were parties to a Notice of Security Interest in U.S. Trademarks dated as of April 30, 2009 (the “Security Agreement”), pursuant to which Grantor granted a security interest to Bank in certain trademarks (“Trademarks”) and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Bank, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on May 13, 2009, at Reel 3986, Frame 0661; and

WHEREAS, Grantor has requested that Bank release its security interest in the Trademarks and Trademark Collateral and reassign any and all rights in the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Bank hereby releases its mortgage on, pledge of and security interest in, all right, title and interest of the Grantor in and to the Trademarks, together with all the goodwill of the business symbolized by the Trademarks, and the registrations or applications for registration thereof, and all proceeds thereof, including, without limitation, any royalties, claims for infringement and proceeds of sale or other disposition thereof (the “Trademark Collateral”).

2. Bank hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Bank, any and all of Bank’s right, title and interest in and to the Trademarks and the Trademark Collateral.


