DECLARATION

The undersigned,

Mr Aart Daniël Gerard Heering, civil-law notary, officiating in Amsterdam;

declares:

- that the following documents have been submitted to him:
  - a copy of the deed of merger between *Hoechst Marion Roussel B.V.* and *Rhône-Poulenc Rorer B.V.* executed on September 4, 2000 before Mr Michel Dick van Waateringe, civil law notary officiating in Amsterdam (The Netherlands).
  - A copy of the deed of amendment of the articles of association of *AVENTIS PHARMA B.V.*, formerly named Hoechst Marion Roussel B.V. executed on September 5, 2000 before Mr Michel Dick van Waateringe, civil law notary, officiating in Amsterdam (The Netherlands)
- that from the deed of merger it appears that the company Rhône-Poulenc Rorer B.V. has been absorbed by and merged in Hoechst Marion Roussel B.V. ;
- that this absorption has taken place in conformity with the regulations to Dutch law on legal mergers;
- that within the framework of those regulations, the assets and liabilities of Rhône-Poulenc Rorer B.V. have been transferred under universal succession of title to Hoechst Marion Roussel B.V. as a direct consequence of the merger;
- that this transmission under universal succession of title was effective as from September 5, 2000;
- that also as a consequence of the merger, Rhône-Poulenc Rorer B.V. has ceased to exist as from September 5, 2000 and that Hoechst Marion Roussel B.V., established at Bijenvlucht 30, 3871 JJ Hoevelaken (The Netherlands) continues the business of Rhône-Poulenc Rorer B.V.
- that from the deed of amendment of the articles of association aforementioned it appears that the name of the company Hoechst Marion Roussel B.V. has been changed in *Aventis Pharma B.V.* with effect on September 5, 2000.
