
1. The name of the Corporation is:

Name. The name of the Corporation is "Spireon, Inc." The Corporation's original Charter was filed with the Secretary of State of the State of Tennessee on November 3, 2009.

3. This Amendment was duly adopted by the directors of the Corporation by written consent dated as of January 31, 2012 and by the shareholders of the Corporation at a Special Shareholders Meeting on February 23, 2012.
