The Assignor shall make no further use of the trademarks described in the Trademark Registrations in the United States or anywhere in the world.

EXCEPT AS OTHERWISE SPECIFICALLY PROVIDED HEREIN, ASSIGNOR MAKES NO WARRANTY WHATSOEVER, AND HEREBY EXPRESSLY DISCLAIMS, ANY AND ALL WARRANTIES, EXPRESS, IMPLIED, OR STATUTORY, AS TO THE TRADEMARK REGISTRATIONS. ASSIGNEE ACKNOWLEDGES AND AGREES THAT THE TRADEMARK REGISTRATIONS ARE BEING ASSIGNED AND TRANSFERRED IN AN "AS IS", "WHERE IS" CONDITION, WITH ALL FAULTS. WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, ASSIGNOR MAKES NO WARRANTY AS TO THE VALIDITY, FITNESS, OR SUITABILITY FOR A PARTICULAR PURPOSE OF ANY OF THE TRADEMARK REGISTRATIONS, AND, BY EXECUTION OF THIS ASSIGNMENT, ASSIGNEE AFFIRMS AND AGREES THAT (A) ASSIGNEE HAS NOT RELIED ON ASSIGNOR'S SKILL OR JUDGMENT TO SELECT OR FURNISH THE TRADEMARK REGISTRATIONS FOR ANY PARTICULAR PURPOSE, (B) ASSIGNOR MAKES NO WARRANTY THAT THE TRADEMARK REGISTRATIONS ARE FIT FOR ANY PARTICULAR PURPOSE, AND (C) THERE ARE NO REPRESENTATIONS OR WARRANTIES, EXPRESS, IMPLIED OR STATUTORY, WITH RESPECT TO THE TRADEMARK REGISTRATIONS.
