

Capitalized terms used in this notice and not otherwise defined herein have the meanings specified in the Guaranty and Security Agreement. The rules of construction specified or referenced in Section 1.01 of the Guarantee and Security Agreement also apply to this Notice. This Notice shall be construed in accordance with and governed by the internal laws of the State of New York applicable to contracts made and to be performed wholly within such State, without reference to any choice or conflict of laws or rules which might otherwise be applicable. This Agreement may be executed in two or more counterparts, each of which shall constitute an original but all of which when taken together shall constitute but one contract. Delivery of an executed counterpart to this Agreement by facsimile or other electronic transmission shall be as effective as delivery of a manually signed original.


