**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS**

This Release, made as of September 12, 2013, is given by Village Bank & Trust (“Lender”) to Stagnito Partners, LLC (“Stagnito”), as follows.

WHEREAS, Stagnito and Lender are parties to that certain Intellectual Property Security Agreement dated as of November 22, 2011, under which Stagnito granted to Lender security interests in certain of Stagnito’s intellectual property rights (“IP Rights”), including without limitation trademarks, trademark applications, trademark registrations, service marks, service mark applications, and service mark registrations, including without limitation those set forth on Schedule A attached hereto (the “Marks”); and

WHEREAS, Lender now wishes to release and restore all right, title and interest in and to the IP Rights to Stagnito and to dissolve any and all liens and encumbrances related to the IP Rights.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Lender hereby releases, discharges, quit claims and relinquishes unto Stagnito all security interests in the IP Rights granted to Lender by Stagnito, including without limitation the interests in the Marks recorded in the United States Patent and Trademark Office on December 13, 2011, at Reel 4677, Frame 0118.
