As noted in the Section 7 Request filed by InduSoft, Inc. (“Registrant”) with the United States Patent and Trademark Office (“Office”) on or after the date of this Certificate of Amendment filing before the Assignment Services Division of the Office (“Division”), Registrant inadvertently filed the applications that matured to Registration No.’s 3,946,530 (CEVIEW), 3,946,531 (EMBEDDEDVIEW), and 3,965,862 (RAPID APPLICATION CONFIGURATION ENVIRONMENT (RACE)) (collectively, the “Registrations”) in the name of its recorded Assumed Name instead of its legal name, which at the time each application was filed was “InduSoft Business Development, Inc.” a corporation of Texas.

After the Registrations issued, Registrant changed its legal name from “InduSoft Business Development, Inc.” to its Assumed Name, “InduSoft, Inc.,” a Texas corporation, on June 29, 2011.

Since “InduSoft, Inc.” a Texas corporation is already the owner of record for these Registrations, no ownership details need to change. However, to retroactively correct the chain of title for these Registrations, Registrant is filing Section 7 Requests for the Registrations before the Office, as well as this Certificate of Amendment before the Division.


