Trademark Security Agreement

Trademark Security Agreement, dated as of September 18, 2013 by MAAX US CORP., a Delaware corporation (the "Grantor") and HSBC BANK CANADA, in its capacity as administrative agent pursuant to the Credit Agreement in its capacity, the "Administrative Agent").

WITNESSETH:

WHEREAS, Grantor is party to the U.S. Security Agreement dated September 18, 2008, as amended on September 18, 2013, (the "Security Agreement"), in favor of the Administrative Agent pursuant to which the Grantor is required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Administrative Agent, for the benefit of the Secured Parties, to enter into the Credit Agreement, the Grantor hereby agrees with the Administrative Agent as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

SECTION 2. Grant of Security Interest in Trademark Collateral. Grantor hereby pledges and grants to the Administrative Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its respective right, title and interest in, to and under all the following Security Agreement Collateral of Grantor:

- (a) Trademarks of Grantor listed on Schedule I attached hereto;
- (b) all Goodwill associated with such Trademarks; and
- (c) all Proceeds of any and all of the foregoing.

SECTION 3. Security Agreements. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Administrative Agent pursuant to the Security Agreement and Grantor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademarks made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control. For the avoidance of doubt, the grants hereunder by Grantor party to the U.S. Security Agreement and the relationship hereunder between Grantor and Administrative Agent shall be subject to such agreement including the governing law provision thereof. For the avoidance of doubt, the grants hereunder by Grantor party to the Canadian Security Agreement and the relationship hereunder between Grantor and Administrative Agent shall be subject to such agreement including the governing law provisions thereof.


SECTION 4. Termination. Upon the termination of the Security Agreement in accordance with Section 6.06 thereof the Administrative Agent shall execute, acknowledge, and deliver to Grantor an instrument in writing in recordable form releasing the collateral pledge, grant, assignment, lien and security interest in the Trademarks under this Trademark Security Agreement.




