TRADEMARK ASSIGNMENT

Assignor is the owner of U.S. Trademark Registration No. 1,216,719, registered November 16, 1982, for ROMANSTONE ("the Registration"). Assignor's rights in the mark ROMANSTONE and the Registration shall be collectively referred to as the ROMANSTONE Trademark.

Furthermore, Assignor specifically assigns to Assignee all its claims (if any) to recover for any infringement or other violation of the ownership rights of the ROMANSTONE Trademark, whether such infringement or violation occurs in the future or has occurred in the past.
